This is to advise you officially that on June 21, 2007, the Real Property Appraiser Board approved the seminar "Residential Cost Approach – ON-LINE" for continuing education credit. As you know, the provider is responsible for seeing that the education activity meets for the full number of hours for which it is approved, that the subject matter is taught as submitted in your application, and that the approved instructor/s are teaching the seminar. Please remember that the Rules and Regulations of the Appraiser Board, Title 298, NAC, Chapter 4, section 14 requires an alphabetical listing of students who have met the requirements of completion must be submitted to the Board within 90 days of conclusion of the activity. This office suggests sending the report after each seminar presentation as the reports are subject to federal subcommittee auditing procedures. The listing should include the class approved title, instructor, date and location. After initial approval, the provider is required by the Rules and Regulations, Section 010 to notify this office of any content or instructor changes in advance of offering the activity.

As a provider of appraisal education, you have an important role in assisting Nebraska candidates in meeting federally mandated requirements of licensure and certification. Your individual assistance in complying with the procedures described in the application packet will help facilitate the licensure/certification process of your students.
